- I have been part of AkioAIR since its founding. I auditioned for the company and accepted their contract because other companies would not let me transfer my indie persona "Athena Nightingale."
- Since the beginning, we have had issues with getting to debut. It took a year to debut us finally. My contract was signed in June 2021. We debuted in March 2022.
- Jason almost did not debut us because of these problems. He started to lose faith in himself and did not want to delay our debuts. S1 gen wanted to delay debuts because we were barely prepared. I spoke to him about it and encouraged him to keep going and agree to postpone the delay.

- Fast forward to Oct-Nov 2022. This was the first time I went on a significant hiatus because, during then, I was under extreme pressure from my real job and Vtubing. I also started developing mental health issues and had to

seek professional help. So I wanted to leave AkioAIR along with another talent, RoaFen, but Jason kept telling me to wait to announce my graduation because it would harm the company image (to have 2 talents leave simultaneously)

- I decided to stay because Jason promised to support more of my projects and even fund 1 cover song a month at the least. That never happened as I continued to ask for support.
- Also, on another matter, I wrote, composed, and directed our group's debut song in Nov 2021. I did not ask to get paid, but since it was not up to Jason's standards and they lacked the funds to get proper animators for the MV, the release was delayed by a year. I felt severely disrespected as the point of a debut song is to premiere it at our debut. I worked tirelessly (even on my shifts at the hospital) to write lyrics, compose, and coordinate this project.

That being said, we think the production of covers has been too fast that I think it would be best if we slow down the cover productions a bit.

I know that you love covers, but that being said, in terms of managing a channel, cover are meant to advertise your channel since they don't make money and is pretty heavy on the cost side. They are good long term investments, but not really best to hope that they bring monetary support in the short run.

Legal has not pursued any actions on you at the moment because the contract and the nature of the breach is different with the rest of Season 2. The damage Season 2 has caused to company is far more significant and a more serious issue, our legal decides to handle it with priority, we would only loop back to handle your issue once we completed most of the legal actions we need take against S2 in breaching their contract.

We'd once offered you the conditions to terminate the contract to peacefully, twice, once before your involvement with S2 (which is simply to wait it out), and the second time after your get yourself involved with S2 for who knows what reason, and we asked for a second condition.

**Both you failed to comply and response in time**, and you expect legal to let you go peacefully?

**I was willing to offer you one last chance to terminate the contract once more with the legal team, so you won't be into legal hot water (who likes that anyways)**, but you just had to screw it up by doing actions that directly breaches our contract. Consider your contribution to the company, I really really wanted to be nice with you and don't want to give you too much trouble, yet you seem to be keep FINDING yourself in more troubles.

**Care to explain the announcement?** You realize you are digging yourself a bigger hole on any unauthorized move you make right? You could have left the company early without any repercussions, and now you are just asking and begging to be sued. Legal just saw the announcement and there's NO WAY I can convince to drop your case.

I'm being serious right now, I would have convinced legal not to pursue you, because honestly speaking you did help a lot with company, and now there's no way I can convince anyone otherwise to not take legal action on you.

You better think of a settlement condition RIGHT NOW, or legal will be serving you the letters. (edited)



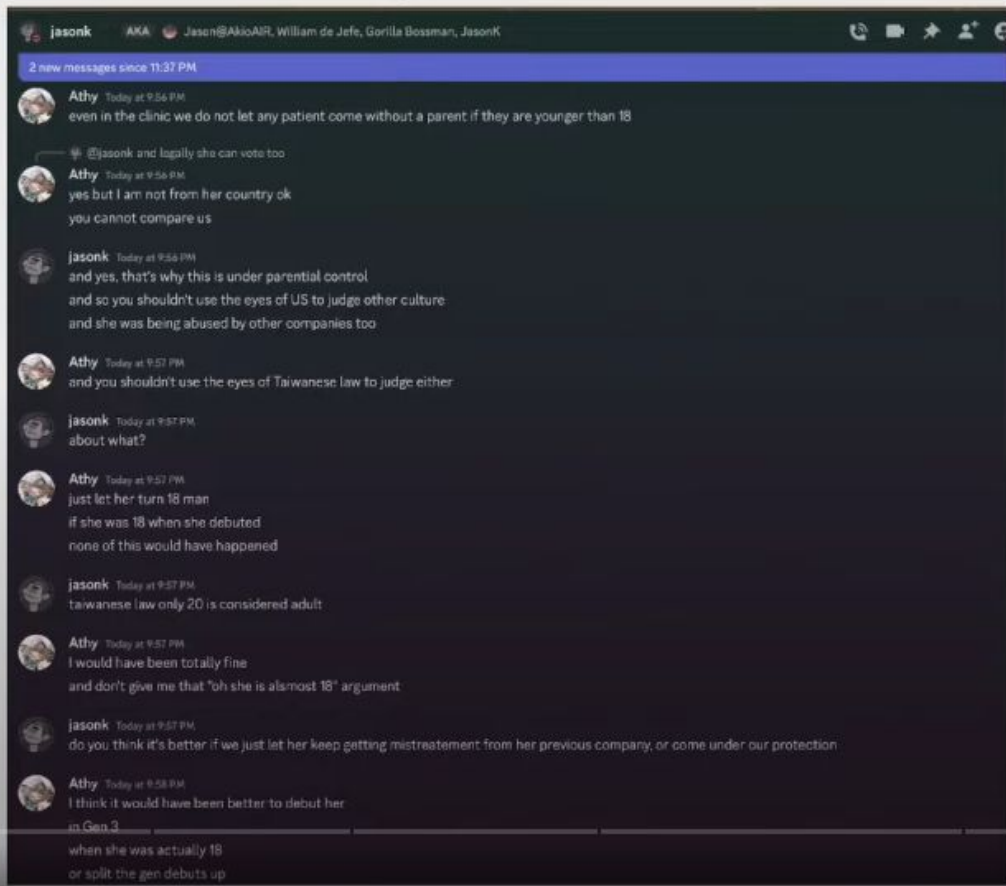

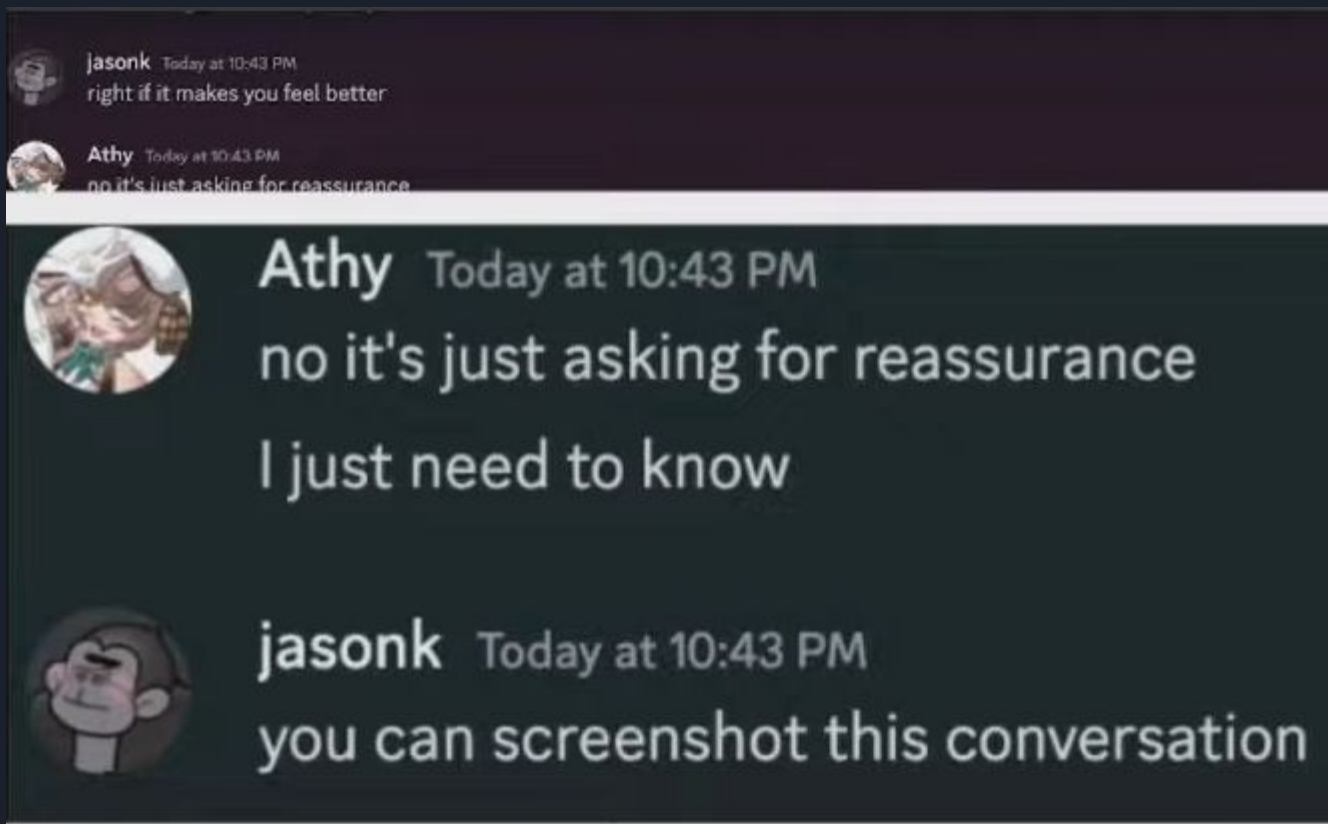

# Anon Agency reveals AkioAIR manager auditioned

False: "We received anonymous information from organizations, this organization being another VTuber agency and reaching out to tell VTS;"

Anon agency: "Yes we had a massive ordeal with them (that being AkioAIR) that we've been avoiding sharing publicly sharing to avoid conflict, long story short they (AkioAIR) attempted corporate espionage against our company. We received an application for our talent auditions from their talent manager. We did not know she was their talent manager at the time. On the audition form we ask about any affiliations with organizations to which she said there is none.


During the interview our team once again confirmed and asked about her background and she made no mentions of AkioAIR. We had her sign a non-disclosure agreement and then we discussed contracts, marketing plans and showcased our models for the generation.


While we ended up not proceeding with her we later found out through various means that our model files and pre-debut plans were being discussed by AkioAIR staff to the season 2 talents in private. We confirmed the individual was in fact their manager based on the voice, her stream appearances and artwork she claimed to draw on her application and portfolio for us." (cont next slide.)

Anon Agency: We compared the voice from the stream to her audition video and it was the exact same. Furthermore she showcased in her application various illustrations, one of which was this one before it was uploaded here. The illustration was credited to Yuufi herself and our team has come to the conclusion that it is possible that she was likely coerced into doing this."






# Vyspire statements

Vyspire is the trainee branch of AkioAIR

I auditioned for AkioAir's trainee program, Vyspire, and made it to the interview round. Jason would regularly, like daily, be in all day long Discord calls with some of the other auditionees in the server. There were maybe 4 or so girls that he very clearly favored over everyone else that he would fall asleep in Discord calls with a few times a week - one time I checked the server a few times throughout the day and every single time he was still in a call with just one of the girls. He also ended up following these girls on social media and made his Discord banner a picture one of them drew of his weird gorilla persona surrounded by all of their Vtuber models. I didn't interact a whole lot in the server because it was very cliquey right off the bat, and a lot of the auditionees seemed way younger than me by the way they typed/acted.

What Motokuma said about the other members of the server getting together to hate on other Vtubers/companies is right. There was a different company that had debuts around the time that had stirred up a good amount of publicity and excitement, and afterwards, one of the auditionees told everyone we all needed to get in a call ASAP to basically make fun of them. Almost everyone in the server, Jason included, was in the call shit talking about all of the talents in the other company.

I was interviewed last because I had to remind Jason 3 different times I still hadn't completed mine after everyone else had done theirs. He drug his feet about it and when we finally set up my interview call, he seemed so incredibly disinterested and acted like I was wasting his time. Vyspire originally touted that if you were accepted, you could get any Vtuber artist you wanted and the company would pay for it. However, it was in this call that he told me they'd actually only contribute a small amount if I wanted to use any other artists besides their "in-house" artist, and that I'd have to cover most of the cost myself.

The server has since been nuked, I'm guessing so no one can take any screenshots or put out anymore damning evidence. My whole experience with this company was incredibly negative and off-putting and I'm glad things are starting to come to light.



Hello False,

I noted that you are currently covering AkioAir and in particular had a stream regarding the audition process. I wanted to add my experience in case there was anything of note that would help close out the story on Akio. I would like to request that I remain anonymous if any of the details are used, thank you!

I filled out the audition form the first week of December 2022. At that time I had watched a video Mew released in July 2022 with Jason regarding auditions at that time and was a bit confused since it seemed like they were reopening or had cancelled those auditions. Regardless, the application form was rather standard in which I mentioned that I had prior experience in another small VTuber agency which I left. There was a section at the bottom asking "Consideration for Vyspire Aspiring VTuber Academy" and whether we wanted to be automatically considered for which I answered "I currently do not live in the US" as it was communicated to be limited to the US due to the sponsors at that time. The Privacy Policy included was strange as it was worded: "Please read our privacy policy before submitting the application, just to make sure you know that we won't sell your sweet voice for whatever purposes or that we won't use it to get around some voice recognition and launch a nuke that way" which I assume is their brand of humour that continues on throughout the audition process.

I received a response less than 12 hours later noting that I made it to the next round in which we answered Creative and Evaluation Questions. Here they asked about our equipment, artist and model preferences, what they dubbed "serious questions" and most memorably the "creative questions" which included a series of 4 short answer questions about an elephant... As an example the first question was: "An elephant walks out of your kitchen and brings up a plate covered with a lid. You are unable to observe the contents within the lid. The elephant then asks you: "This dish contains of meat, vegetables, and bread. Is this a burger, a sandwich, or a salad? And why?" with all the others being similar. In this section they note that it is to demonstrate our creativity and will not put the applicants at a disadvantage if we answer poorly, however these were required questions and a section I've never come across in other auditions. It also seemed to mirror the strange brand of humor AA has on their website About Us page which also talks about burgers and salads.

Once again, less than 12 hours later I received an email, from Jason's AA email this time, noting that I've moved on to the 90 minute interview stage and provided the discord server link. We were informed to prepare a game that we would mock stream, any other streams (singing, drawing, zatsudan, etc), and that a chat to discuss the VTuber career at AA would take place. There was a warning that other candidates would be on the server and if we didn't want to share our name to use an alt account.

From my recollection the interview stage spanned over 2 months which was longer than I'm used to and applicants were able to select a time slot to interview up to the end of Jan. Upon entering the server and seeing the messages from other applicants it seemed that the interviewers were Jason, members of the "Akio Air Audition Committee" per the discord role of which there were many of these individuals and potentially the talent manager Yuufi and Mew. Mew was the only AA talent I noted to be in the server but it was not explained what capacity if any she had on the process.

During my time slot Jason and 2 members of the "audition committee" were present with these 2 members remaining muted and unIntroduced for the full duration of the interview. Jason's first question to me was, what happened with my old VTuber agency. I noted that I didn't like the management style and there were communication issues that led to talents leaving. Which I recall he responded, "oh that's it? Was there any other drama? I thought there would have been drama since your models looked nice" in which I repeated that it was mainly due to management and communication. He responded to the effect of, "I thought there would be something more dramatic or some tea." I was rather shocked that these were the first questions he asked me in the interview and that he seemed to be looking for details of potential "drama" instead of my experience. Following my answers he also seemed to lose interest. One of the main draws of AA for me was Athy who I was aware joined AA with her old identity. As I was in the process of getting my own indie model I asked whether it would be possible to retain my identity. He asked for wips and commented, "was it expensive?" to which I did not disclose an exact figure. He then commented that the model was not anime like enough even though it was anime style and commented on the shading. He then mentioned that I could possibly join Vyspire where instead of providing a model they would let me use mine as the board would not likely let me use it in Gen2. He noted that though I wasn't based in the US it was likely fine as they were planning to expand. I recall at some point I asked whether there was any specific content or personality they were looking for in Gen 2 talents to which Jason answered that they were looking for a Pippa. During the time I did the mock stream, there was no chat interaction and afterwards no comments were made on my performance.

Overall, the experience made me feel like I quickly moved through the stages due to my mention of prior agency experience and Jason's interest in learning about the "tea". The mention of investors, a board, and committees were warning bells to me as small corpos seem to love throwing these terms around. I hope with the coverage of AA, the Akio girls can continue pursuing their VTuber dreams without the weight of the Akio Air company.
